

Criteria Revised for Determination of Social Security Disability Based on Hearing Loss

The Social Security Administration (SSA) published a final rule revising and updating the disability criteria for evaluating hearing loss, effective August 2, 2010. The rule allows audiometric testing to be performed by, or under the direct supervision of, an otolaryngologist or a qualified audiologist. State licensure or registration determines qualified status. If there is no licensure/registration available, the audiologist must be certified by ASHA (CCC-A) or by the American Board of Audiology (ABA). The regulations are set forth in the Listing of Impairments (Sections 2.00 and 102.00--Special Senses and Speech--of Appendix 1 to Subpart P of Part 404, in Title 20 of the Code of Federal Regulations). The amended regulations were published in the Federal Register, June 2, 2010.

The audiometric testing requirements are segmented between those with and without cochlear implants (CI) and by age. Without a CI, testing requirements are specified in four age groups through age 17. For those with CIs, a child is considered disabled until age five or for one year after initial implantation, whichever is later. After age five, word recognition testing is required.

SSA included clarification in the rule's preamble regarding the provision in sections 2.00B1c and 102.00B1c that permits audiometric testing by a non-audiologist under the supervision of an otolaryngologist. SSA accepted the requirement that non-audiologists "conduct testing only under direct supervision, in accordance with Medicare regulations requiring the physician to be present in the office suite when the service is being performed and to assist if necessary." However, rather than include this statement in regulation, the SSA stated in the preamble that, "We will provide guidance to our adjudicators on how to apply the rule in our [SSA] instructions and training."

SSA rejected comments that the results of audiometric testing conducted independently by hearing aid specialists (also called Hearing Instrument Specialists - HIS) be accepted. SSA stated that the educational and other qualifications required for licensure or certification as an HIS are less comprehensive than those of otolaryngologists and audiologists and can vary from place-to-place. However, if an HIS conducts the testing under the direct supervision of an otolaryngologist, the evidence would be acceptable audiometric testing both for establishing a medically determinable impairment and for assessing its severity.

Previously, this rule stated that an otologic examination by a physician should precede audiometric testing. This has been revised to clearly allow the testing to occur before or after the complete otologic examination. Also, the regulation states that the audiometric testing "should," rather than "must" be performed within two months of the otologic exam. Thus, as stated in the preamble, SSA adjudicators would be allowed to use evidence that is outside the two-month period in appropriate cases.



ASHA continues to advocate for members as well as our clients. ASHA's 2010 Public Policy Agenda and issue briefs on each of the areas mentioned below can be found at www.asha.org/advocacy. Areas of focus include the following:

- Medicare therapy cap
- Early Hearing and Detection
- No Child Left Behind (NCLB)
- Health Care Reform
- Student Loan Forgiveness for Service in Areas of National Need
- Individuals with Disabilities Education Act (IDEA)
- Medicare Telehealth Coverage for Audiology and Speech-Language Pathology Services

The latest news from ASHA includes:

- The United States Department of Education has a new website, www.data.ed.gov. This site will provide access to information about the Department of Education's grant programs.
- A temporary Medicare Fee schedule was signed into law on June 25, 2010. The "Preservation of Access to Care for Medicare Beneficiaries and Pension Relief Act of 2010" was signed into law by President Obama. It allows for a 2.2% update to the fee schedule payment rates.
- Medicare nonparticipating speech-language pathologists and audiologists can now be enrolled as participating providers by filling out the Medicare Participating Physician or Supplier Agreement (CMS-460) form and sending to their Medicare contractor. Kentucky's Medicare contractor is National Government Services. The change will apply to claims submitted after the form is processed.
- New Audiology Transmittals were released by Medicare, June 10, 2010. These revisions and clarifications to the Medicare policy manuals are effective July 28, 2010. They address the "use of audiometric technicians, computer-administered audiometric devices, reevaluations, services rendered as an employee or contractor of a physician assistant or nurse practitioner, and hospital outpatient services."
- On June 14, 2010, ASHA's National Center for Evidence-Based Practice in Communication Disorders provided members with four evidence maps. The maps are Autism Spectrum Disorders, Traumatic Brain Injury (Adults), Traumatic Brain Injury (Children) and Parkinson's Disease. They can be accessed at www.asha.org/research. The maps will be updated quarterly and more maps will be added in the future.

The KSHA-ASHF 2011 Clinical Achievement Award

The KSHA-ASHF Clinical Achievement Award for 2011 will be presented to a speech-language pathologist or audiologist in Kentucky for demonstrated contributions to the advancement of knowledge in clinical practice as evidenced by significant recent accomplishment within the past six years in either area. This award is co-sponsored by the Kentucky Speech-Language-Hearing Association (KSHA) and the American Speech-Language-Hearing Foundation (ASHF). The selection from among our state nominees will be made by 2/3 vote of the KSHA Executive Council. The individual selected by KSHA will receive a certificate from ASHF in addition to being named the 2011 Kentucky Clinical Achievement Award Winner. The 2011 recipient will be Kentucky's nominee for the ASHF's National DiCarlo Award for Outstanding Recent Clinical Achievement. The national winner of the DiCarlo Award will receive a recognition plaque and a grant of \$2,000 to further the project(s) upon which the award is based and will be recognized at the 2011 ASHA National Convention. This award is announced at the Annual Luncheon during the KSHA Convention and is typically presented by the individual who submitted the nomination.

Criteria for Award

Our state recipient and the national DiCarlo honoree will be chosen for advancement of knowledge in clinical practice as evidenced by significant accomplishments within the past six years in the advancement of clinical service in speech-language pathology and/or audiology. Nominees are not limited to any particular type of clinical achievement or activity. Some eligible activities or accomplishments include:

- Achievement with a single client or group of clients
- Achievement in a state or local organization or government agency activity
- Clinical service programming
- Clinical testing, research or administration
- Program development

Procedures for Nomination

The Honors Committee and ASHF Board of Directors are totally dependent on the information provided in the nomination document. Thus it is important that the information submitted be as complete and accurate as possible. Nominations will be reviewed solely on the information submitted.

- The nomination should not exceed 10, single-spaced typed pages including any letters of support
- Description of the significance of the recent achievement
- Include nominee's name, professional title, place of employment, address and daytime telephone number
- Explanation of how the nominee's actions have advanced knowledge in the area of clinical practice
- Description of the outstanding clinical achievement (include information of when and where the specific achievement(s) took place)
- Explanation of the nominee's role in the achievement

Certificates of Appreciation from the Kentucky-Speech-Language Hearing Association

The KSHA Honors Committee invites nominations for KSHA Certificates of Appreciation to be awarded at the 2011 Convention in Covington in February. For Certificates of Appreciation, these individuals are not KSHA members or SLPs or audiologists, but typically *members of the community* who are particularly supportive of individuals with communication disorders or of the professions.

The Honors Committee will recommend potential recipients to the KSHA Executive Council which must approve recipients by 2/3 affirmative vote. Please take time to nominate anyone you feel should be considered for this award. We invite the recipients to the luncheon at the convention to receive their award and the person who submitted the nomination will typically present it. There can be more than one award.
